Cannabinoids were quantified with an HPLC/DAD system on: 27-Dec-2022. Terpenes were quantified with a GC-MS system on: 27-Dec-2022. Mycotoxins and Pesticides were quantified with an LCMS system on: 26-Dec-2022 and 26-Dec-2022 respectively. Heavy Metals were quantified with an ICPMS system on: 27-Dec-2022. Water activity was quantified with a water activity meter on: 27-Dec-2022. Moisture content was quantified by Loss on Drying on: 27-Dec-2022. Sampled in accordance with PRO.S.106D Sampling NJ. Unless otherwise indicated, results were reviewed and verified by the Lab Director, and issuance of this CoA was authorized by the
